SAFETY CORNER: A monthly reminder of some of the rules that are important for the safety of our community.

ALL residences shall provide adequate living, sleeping, cooking and sanitation, with a minimum square footage of 720 feet for anticipated use of not more than four (4) persons; with additional minimum of 100 square feet for each additional person. Exceptions should be considered on a case by case basis. (July 2022)

Fire Pits may NOT be used during a Burn Ban within Logan County or TL area..... Anyone in violation of these rules will be assessed a minimum fine of \$250.00.

The Cannonball that Wouldn't Stop

One of the zany experiments staged by the "Mythbusters" television show nearly turned into a suburban tragedy in Dublin, California when the crew fired a homemade cannon toward huge containers of water at the Alameda County Sheriff's Department bomb disposal range.

The cantaloupe-sized cannonball missed the water, tore through a cinder-block wall, skipped off a hillside and flew some 700 yards east, right into the Tassajara Creek neighborhood, where children were returning home from school at 4:15 p.m. There, the 6-inch projectile bounced in front of a home on quiet Cassata Place, ripped through the front door, raced up the stairs and blasted through a bedroom, where a man, woman and child slept through it all, only awakening because of plaster dust.

The ball wasn't done bouncing. It exited the house, leaving a perfectly round hole in the stucco, crossed six-lane Tassajara Road, took out several tiles from the roof of a home on Bellevue Circle and finally slammed into the Gill family's beige Toyota Sienna minivan in a driveway on Springvale Drive.

That's where Jasbir Gill, who had pulled up 10 minutes earlier with his 13-year-old son, found the ball on the floorboards, with glass everywhere and an obliterated dashboard. "It's shocking - anything could have happened," Gill said after the van had been taken away as evidence, along with the cannonball.

"Crazy, crazy, crazy," said Sgt. J.D. Nelson, a spokesman for the Alameda County Sheriff's Department. "You wouldn't think it was possible."

As I read about this story it seemed to me that what we say in the spirit of anger or just an uncaring spirit does damage way beyond what we think! Crazy, Crazy, Crazy!

- -Meeting started 6:02pm
- -Stacey motioned to approve minutes. Porscha second. All in favor.
- -Elephant Tax stickers: We have organizing stickers that have QR codes that will help us know by photos what is in each container. At the 1st of the year we will get together and go through each tub and start organizing and decluttering. In the shed is Christmas & Valentines Day stuff, in the container is food prep but needs to be thrown away because it was big bombed, and then Christmas stuff as well.
- -The container: Rachelle is frustrated & in her opinion wants to paint it, clean it, & use it for storage. Budget wise we need to do other stuff they is more important. There is a debate about weather permanent water source should be put there. Should the container stay there or be moved somewhere else? That is where 4th of July is hosted. There was a budget already set by the Board of Directors to paint the maintenance building and the container, but hasn't been done just yet. There is possibly black mold inside the container. Mike Fellers is being called to test it. How much money is needed to get it in usable conditio? Tabled until next month meeting.
- -The lease; We did sign the old lease until next months Board of Directors meeting. We are waiting for more board members & revisions will be looked at.
- -Fall Festival update: Denise is going to get with other board members to sponsor a game. Dane, Rachelle, & Monica will be in concession. Concession will be in the restauran. Rachelle will email the menu out to everyone.
- -Inflatable: Inflatables are expensive and we use them at almost all big events. Maybe we can spray the common areas if we do get one. But who is responsible for spray for stickers? Would it not be maintenance because that is upkeep of Twin Lakes property. Do we have the power to spray our own land without a license since it is private property? Do we need to be permitted to own an inflate? If we buy one we can rent it out to members when they rent the clubhouse.
- -Booster Club survey: 95% of the comments were positive. We kind of got an idea of what the community is looking for. A combination of big & small events. Doing events for our community only. Free events was 50/50.
- -We are going to start recording all Booster Club & Committee Meetings so minutes can be verified as being able to have word for word.
- -Some events we could add could possibly be breakfast for mothers a week before Mothers Day & breakfast for fathers a week before Fathers Day, m-We are going to hang the Boost Club finances in the clubhouse & office for every to be able to see. Minutes & Agendas will go out in the monthly newsletters. Our financials can also be part of the report at the monthly BOD meetings. They can also be emailed to anyone at anytime, all officers should have access to the drive, we just need to set it up. Rachelle said Brooke is transparent and copy & pasted the financials. Do we need an annual budget? We will set one out for the entire year.
- -Breakfast Fundraiser: We spent \$270 & profited \$250-\$260. The roasters the Booster Club has been using are the Fire Departments and Rachelle said they don't care that we use them, but over the course of 3 years of using them only to the 4 work. Porscha made a motion to either reimburse the Fire Department for 3 roasters or to buy 3 new ones. It will be up to the Fire Department how they are paid back. Stacey second. All in favor.
- -November 24th fundraiser: We will use the hash browns Kelli & Pete donated to make potato soup We will also serve cheddar bay biscuit. Stacey made a motion for a \$300 budget. Terri second. All in favor.
- -Breakfasr with Santa: We always waste so much food. Do we need to make it more simple? We did not profit a lot last year. We will just use what we have decoration wise with limited food like just pancakes with toppings juice, milk. & coffee, Reese might do photos for free. People will just use their phones. Brooks is 100% committed to being Santa again. He's growing his beard out and everything. Denise made a motion for \$300 budget. Stacey second. All in favor.
- -T-Shirts: A new flyer for reminder.
- -Walmart Plus has been cancelled. Rachelle will ask Brook about Quick Books. We need to categorize what expense is for what fundraiser.
- -Moving the craft fair to 4th of July only just because of foot traffic.
- -Christmas lights: We will do the fence down the entry on both the East & Weat side, The Memorial, & Squirrel if we have time.
- -Yearly calendar tabled until next month meeting.
- -Denise motions to adjourn at 7:23. Terri second. All in favor.

October 2024 Monthly Board Meeting Notes

Meeting opened at 7:00 PM with flag salute and prayer.

Nine (9) of fifteen board members attended. Minutes from Sept meeting approved with one correction. Corrected minutes will be sent to all members shortly.

We went thru our ISO audit this year and just got our report back a few weeks ago. Previously we we an 8b and now we are a 7.

If you don't know the lower the number, the better the rating for the insurance companies.

Our biggest hurdle for TLFD is the water source supplied by the community and throughout the district.

"IT's DRY" Logan County is currently in a burn ban through November 7th. This is implemented by the county commissioners when the fire weather situations meet all the criteria.

The grass and trees have for the most part have gone dormant, please keep in mind that fire prevention starts with you. Please be mindful where you dispose of your ashes and extinguish all campfires after enjoying them either on the river or at home.

We have also been helping our neighboring departments over the last few weeks with wildland fires.

The new tanker has been on several of these incidents and is working well.

Saturday Oct 26^{th,} we had our annual kids fire awareness training at the station and also that evening during the fall festival get to gather. We had kids from the age of 1 up and they all seemed to enjoy themselves. Thanks to everyone that made the kids training and the fall festival a success.

Today, October 29th found our community in grave danger. Fire! A wild-land fire started along Highway 33 just south and west of Twin Lakes. The 45 plus south winds soon pushed fire across Highway 33 into farm land and cedar trees so common in Oklahoma. As the fire raged, firefighters, our firefighters, began to attack this deadly scourge.

Twin Lakes was a war zone.

Our entire fire department responded but this fire was an out of control blaze. Quickly understanding additional help was needed a call for help was sent. Residents were advised to evacuate by our department.

The exodus began slowly then more rapidly. Members who were at work or off property rushed to get home. Many members went to family living close to Twin Lakes and out of harms way. Many went to four corners or Crescent. Access to Twin Lakes was closed while a battle raged.

The wait began, will our great community survive?

Local media predicted the fire would miss TL.

Their prediction was correct only because courageous volunteer fire departments were attacking the fire.

Factual information was scarce. Rumors or haft truths were abundant. Now all we could do was wait.

That day was a lesson in real character. Firefighters charged into battle. Most only knew they were needed. They left family, jobs, and homes to protect people they do not know. True character.

Their mission: protect people. Property is important but secondary to lives. Fire departments as close as Cashion and as far away as Clinton began arriving for battle. Not a battle but a war awaited them. Armed with skill, courage, and determination the met the enemy, an out of control fire. Each know fire only knows how to destroy. They advanced like an army in battle. True courage.

These warriors had begun to turn the tide, the fires out of control rampage had been slowed and then controlled, not totally stopped but no longer an absolute danger to Twin Lakes. The fires advanced towards Twin Lakes, but it had met its match. A Firefighter.

Residents were allowed to come home a little after 6 PM. The war was not over but controlled. Firefighters through the night continued to fight hot spots and remain on watch for new fires.

There are no words which can thank each and every fighter and law enforcement for their courage and talent. They know we are grateful.

Next time you see a firefighter thank them. They may have not fought our fire but the same courage is in them.
