Rumors And Gossip

"For I am afraid that when I come I may not find you as I want you to be, I fear that there may be discord, jealousy, fits of rage, selfish ambition, slander, gossip, arrogance and disorder." -2 Corinthians 12:20

In Fall 2022, the Gas app exploded in popularity among high schoolers, but a vicious, unfounded rumor caused its popularity to nosedive, confounding its founders in the process.

Titled after the internet slang "gas up" which means to flatter someone or give them good feelings, the app allows students to share anonymous compliments with their peers. But mere weeks after it reached No. 1 on the Apple store, rumors began circulating that Gas was being used for sex trafficking.

One user said, "I have a Glock and I'll come into your house and kill all of you," said Nikita Bier, the startup entrepreneur who founded Gas. "The messages are very detailed, and they'll send like 150 of these messages because they're so angry. We have had emails saying, 'what you're doing is disgusting and I've reported you to the FBI.' We get countless messages every day from users about it."

According to Bier, the rumors intensified after parents, teachers, news reporters, and public safety organizations amplified them without knowing if they were true or not.

One such agency was the <u>police department in Piedmont</u>, <u>Oklahoma</u>, which later had to post a retraction. Piedmont Police Chief Scott Singer later said, "That posting was the result of a post that was forwarded to us, which we later learned to be a bogus posting. As a result, we talked with the CEO of Gas, and we have determined it was a bogus posting. We have removed that from our Facebook page and informed the schools that any postings about that were discovered to be false."

Bier says, "The app grows on its own, but dealing with the hoax requires a lot of labor." He's tried a variety of strategies to counter the misinformation, but it seems none of them are very effective. "The challenge is that you can only fight memes with memes. If it's not easily screenshotable and exciting it's not going to get more visibility than the original message."

Nothing can ruin a good community like poor judgment and unbridled gossiping. As Christians we MUST ALWAYS be ready to set an example both by what we say and what we choose NOT to say.

"Get rid of all bitterness, rage, anger, harsh words, and slander, as well as all types of evil behavior. Instead, be kind to each other, tenderhearted, forgiving one another, just as God through Christ has forgiven you." -Ephesians 4:31-32

A GOOD REMINDER!

Rabbi Joseph Telushkin, author of Words That Hurt, Words That Heal, has lectured throughout this country on the powerful, often negative impact of words. He often asks audiences if they can go 24 hours without saying any unkind words about, or to, another person. Invariably, a small number of listeners raise their hands, signifying "Yes." Others laugh, and quite a few call out, "No!"

Telushkin responds: <u>"Those who can't answer 'yes' must recognize that you have a serious problem. If you can't go 24 hours without drinking liquor, you're addicted to alcohol. If you can't go 24 hours without smoking, you're addicted to nicotine. So, if you can't go 24 hours without saying unkind words about others, then you've lost control over your tongue."</u>

- 4. Restaurant Review: Mark Hiatt The Cooksey's asked for an extension of the decreased rent until June with a re-evaluation then. In January, the association paid a \$2000 propane bill and \$400 electric bill for January and February each month. Motion to increase and accept rent of \$400 for March and April with no 2%: Mike Gilliam Second: Jerri James 1 opposed Carried
- 5. Site Plan Committee: Jerri James Met Tuesday, February 20th. Rachelle would like to see a basketball half court be constructed at a location either South of the Fire Department by the Chapel or on the East side by the dumpsters where there is already a pad. She has a concrete bid of \$13,000.

Fire Department: Mike Gilliam said that the sales tax passed and thanked those that voted for that. Those funds will be available, if needed. The FD is looking to replace the 200 gallon tanker with a 400 gallon.

Lake project progress presented by a member. Activity has been halted. Board officers will discuss further / future activities.


Decision on Booster Club playing court decided. Location, north of Chapel on hill. Site # 2.

Hi Stockholders!

We are in this thing together! We are a team. There is NO Us vs Them, Stockholders vs the Board. Which is why we will be sending out a Survey in the next few weeks to get a feel for what you guys would like to see YOUR Board focus on.

One of the things that I am very passionate about is the beautification of Twin Lakes with a priority of making the lakes better and improving the fishing for my great grand babies. We have been looking at a lot of things from dredging to a long reach trac-ho to what Daniel Coker has been working on and more. In my opinion we should end up with maybe some of each maybe on a small scale as opposed to a very costly complete overhaul, and of course new wells. But this isn't about what I want, it is about what YOU want.

I think we can get a lake that has some deeper holes in it for fish to thrive and maybe a channel down the middle with fish habitat installed. I think we could add a couple of docks on East Lake and one on West Lake. I think we can fix the banks and line part of them with rock to help with the erosion. I think we could set up some picnic tables and maybe a gazebo or two around the lakes. I think we could raise the culvert between the lakes and add another well to improve the water inflow and depth too. I also think we could have a fountain on both lakes. I think we could repair and stain all the fences. As I have said, this isn't about what I want, it is about what YOU want.

If you want some of these things or others that are not on this list, please, when the survey comes out, fill it out and return it. We really do want to know what is important to YOU, the stockholders. I know what I like and what I would like to do, but this is about what YOU want to see done.

One idea that a member passed on to me was that when the Special River Assessments are finished in December this year, we could do another SMALLER special assessment for the Beautification and Improvement of Twin Lakes. This would kind of be like the MAPS project in OKC but on a tiny scale. I was thinking maybe half of the River Assessments or \$500 a lot divided up over something like 42 months would only be \$11. When the \$20 River assessments go away, they could be replaced by that \$11 or so per lot per month which would generate over \$200,000. An awful lot can be done with that especially if you use mostly volunteers. It's just an idea. I think it is a good one, but it is not about what I think, it is about what YOU think.

I think we are so blessed to have this beautiful property we all love, and I also think we are so blessed to have each other. The uniqueness of this place and the diversity of its members is a major strength for us going forward to the future. I think we have a responsibility to preserve and improve this community for future generations. As I watched the sunset after the recent storms, I am asking that we all make a commitment to do just that and be positive in our opinions whether we agree or not. Looking forward to hearing from you all.
